position? Directors receive \$200 per Board of Directors meeting attended. The President receives an honorarium for their term in the amount of \$18,000. The President-Elect receives an honorarium for their term in the amount of \$9.000. The Immediate Past-President also receives an honorarium for their term in the amount of \$9,000. What is the time commitment for this position? Directors serve for a two-year term. Typically, there are nine board meetings a year that last three to four hours each. Additional meetings may be added. Directors are also required to attend both the Ontario Real Estate Association (OREA) conference and the Canadian Real Estate Association (CREA) conference. These conferences generally last for two or three days, sometimes over a weekend.
